Scope of Work:

1. Preliminary Work:

- Inspection of the bus to assess its condition and readiness for towing.
- Checking of tyres, steering lock, and brake system to ensure safe towing operation.
- Removal or securing of any loose parts that may pose safety risks during movement.

2. Preparation for Towing:

- Positioning of the towing vehicle (Recovery Vehicle with Wheel-Lift System).
- Proper attachment of towing equipment such as tow bars, towing chains, or hydraulic lifters at designated points.
- Verification of secure coupling between the towing vehicle and the bus before movement.

3. Towing Operation:

- Transportation of the bus by towing from the Kerala State Science and Technology Museum, Vikas bhavan, Trivandrum to the Science City, Kozha as directed by the officer in-charge.
- Operation to be carried out at controlled speed ensuring road safety and compliance with local traffic regulations.
- Use of pilot vehicle, if required, for guiding and safety during towing. Safe parking of the bus at the destination as per instruction.

4. Equipment and Man power:

- Heavy-duty tow truck / recovery van with hydraulic lifting and towing equipment.
- Chains, safety belts, and towing accessories.
- Skilled driver/operator and technical assistant.
